## Hydro-Mulching Contract



WillSeed agrees to plant a lawn of grass with the hydro-mulching process as defined on the estimate and work order form attached.

## **Customer Instructions**

**Watering Practice**: After the lawn has been sprayed, begin watering one or two days after initial spray date, this lets the mulch harden in the sun before any water comes in contact with it. Avoid puddling and washing of the seeds and/or mulch. In extremely hot weather, three watering's daily may be required. Apply sufficient water frequently to keep the ground and mulch moist. A representative of our firm will check your lawn periodically during the first two weeks to check its progress. (Read the provided watering instructions for more information).

Mow the grass as soon as you have substantial coverage of short, young grass. Discontinue watering one or two days prior to mowing to allow the soil surface to dry. After the first mowing, fertilize the lawn (optional), as defined in the provided instruction sheet. After mowing resume watering on a once-a-day basis for the next five to seven days, then mow again. Begin to water less frequently, but be sure to fertilize and water sufficiently when the colour of the grass begins to loose its deep green colour.

As the lawn matures, reduce watering frequently. Soak periodically rather than frequent light or daily watering's. Once fully established and mature, your grass may go for weeks without watering, depending on how hot and dry the soil conditions are.

## **Limited Warranty**

- 1. WillSeed warrants that all work will be done by a professional and that all materials will be of the highest quality obtainable, applied and designed to produce luxuriant turf.
- 2. WillSeed will have fulfilled its contractual obligations when no bare areas in excess of three (3) inches in diameter exist.
- 3. WillSeed will re-seed or re-spray, (the method used shall be the option of Willseed) any grass requested by the customer that has not developed as described above, for thirty (30) days after installation.

4. WillSeed will check the lawn periodically to see that watering practices are being followed. It is understood and agreed that if the lawn is found dry within the first fourteen (14) days of hydro-mulching. THIS GUAR+ANTEE SHALL BECOME NULL AND VOID.

5. Should there be heavy rains and wash-outs of the HYDRO-MULCHING application within thirty (30) days of installation, all bare areas will be re- sprayed without cost to customer. This includes the seed, fertilizer and mulch application, but does not include any additional topsoil or re-grading, which if needed will be at the customers expense. It is understood and agreed that lack of proper drainage or guttering or run-off from roads or driveways does not gualify as a wash-out.

6. Willseed does not warrant any HYDRO-MULCHED lawn to be immune to fungus disease or insect damage and will not re-spray any lawn for such damage except at customer's expense. The company does try to recommend grass varieties and planting dates for this area that offer the highest probability of success.+

7. This limited warrant is in infect for a period of thirty (30) days from date of installation. If remaining balance is not paid in full within seven (7) days, THIS GUARANTEE SHALL BECOME NULL AND VOID.
